



## **Executive Circle Program – Participant Agreement**

### **Program Overview**

The Executive Circle Program by Bring Women Back to Work (BWBW) is a one-year leadership development initiative designed to empower women with the skills, mentorship, and strategic insights they need to transition into executive leadership roles.

The total cost per participant is estimated at CHF/EUR 15,500. However, thanks to the generous support of BWBW and its network partners, participants are only required to contribute a one-time fee of CHF/EUR 750, with no further financial obligations.

### **Participation & Commitment**

By enrolling in the Executive Circle Program, participants agree to:

- Engage actively in all workshops, mentorship sessions, and leadership training.
- Commit to personal and professional development throughout the year.
- Participate in networking opportunities and contribute to the community.
- Respect confidentiality regarding discussions, insights, and shared experiences.

### **Program Benefits**

As a participant, you will receive:

- Personalized mentorship from experienced executives.
- Access to exclusive leadership workshops and training sessions.
- Opportunities to network with industry leaders and fellow participants.
- Career development resources, executive coaching, and skill-building opportunities.

### **Financial Terms**

- The one-time participant contribution of CHF/EUR 750 must be paid upon acceptance into the program.
- Participants have no further financial obligations toward the program.

### **Withdrawal & Termination**

- If a participant withdraws after acceptance, the program fee is non-refundable.
- Participants who are unable to complete the program due to unforeseen circumstances are encouraged to discuss their situation with the program team.

**BWBW reserves the right to suspend or terminate the program participation for cause with immediate effect in cases of:**

- Repeated failure to meet participation requirements without valid justification
- Non-payment of the program contribution
- Conduct that negatively impacts the BWBW community, its good reputation or its values


